**Contract Terms:**

I acknowledge that the standard installation is \$180.00—\$200.00 plus applicable taxes and it includes the installation and set-up of the radio and antenna, 75’ of CAT5 cable terminated at your router, switch or computer and configuration of your router or computer. Installs exceeding the above criteria will be charged additional fees and will be advised prior to the install. The external radio equipment will remain the property of SureNet and shall be returned to SureNet upon cancellation of service. Client will be billed up to \$1200 should the external radio equipment not be returned. Customer will be responsible to dismantle and return said equipment in good working order at his/her own expense or arrange for SureNet to remove and return said equipment at an additional fee charged to the customer. I acknowledge that any additional equipment such as routers, access points, etc, are not serviced or maintained by SureNet, but are the customers responsibility and are covered by any applicable manufacturer's warranties and technical support. Demarcation point is the Wireless Internet Modem. *New Wireless enrolments have a 1 or 2 year contract.* By signing below you authorize that once your installation has been completed and wireless service is confirmed at your location, a one year contract will begin for Standard Residential service or a two year contract will begin on the Seasonal Residential service. On the Standard Residential service you agree to pay in full the monthly price of your service for a minimum of 12 months as well as a one time installation fee of \$180.00 plus applicable taxes. On the Seasonal Residential service you agree to pay in full the monthly price of your service for a minimum of 6 months per calendar year for a minimum of 2 years as well as a one time installation fee of \$180.00 and a \$10.00 hardware rental per month for off season months the service is not being used. There is a penalty for canceling wireless service prior to contract closing date. If you choose to cancel before your contract closing date you will be responsible to pay 100% of the charges for the remaining months of the contract. Cancellation fee of \$75 applies to all cancellations unless someone else will be taking over the service at the same location. *Service after your contract period will be automatically renewed for another 1 or 2 year term ( 1 year standard residential, 2 year seasonal ) unless cancelation in writing is received 60 days prior to contract end date.* This order form constitutes an order of service by SureNet Communications Group Inc.
